ORDER

As per the e-mail cited 7th above, Ms. C.S.Asha (Serial No.1) in the order cited 6th above has informed unwillingness to join duty. As such it has been decided to issue appointment order to the next candidate from the respective Rank list.

From the list provided by the Divisional Employment Officer (P&E), Ernakulam, the following candidate is hereby offered appointment as Assistant Engineer on contract basis in the Kerala State Pollution Control Board for a period of 179 days from the date of joining duty or till a regular PSC hand joins duty, which ever is earlier on a fixed consolidated pay @ ₹ 43,155/- (Forty three Thousand One Hundred and Fifty five only) per month and subject to the acceptance and fulfilment of the usual terms and conditions of contract appointment. Before joining duty, the candidate should execute an agreement in non-judicial Indian stamp paper worth ₹ 200/- with the Board.

The service of the contract appointee will be purely on temporarily basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory. The appointment on contract basis does not entitle the candidate for being regularised in the service of the Board or confer any claim for regular appointment in future. If any irregularity is noticed later in the recommendation of his name from the Employment Office or in selection of the candidate for posting, his service in the Board will be terminated.

If the terms and conditions of contract appointments are acceptable to the candidate he will report for duty before the Officer at the office of posting within 15 (fifteen) days of receipt of this order with his photo ID, original documents in proof of age, qualification and community / non-creamy layer certificate and will execute the requisite bond of contract . The candidate will have to submit a certificate of his fitness from a Government /Registered Medical Practitioner and a character certificate from a Gazetted Officer. If he fail to join duty on time, posting order issued to him shall stand cancelled automatically and candidate will have no right to claim it .
