**ORDER**

The Chief Environmental Scientist post of Central Laboratory has been lying vacant for want of qualified staff for promotion since 1.04.2015. Sri. V.T Sajimon, Senior Environmental Scientist has been holding the full Additional Charge of Chief Environmental Scientist from 27.02.2019 onwards as per the proceedings read as 1st above. Since the Chief Environmental Scientist is the Head of the Central Laboratory and the long time vacancy had affected the functioning of the Laboratory, Sri. V.T. Sajimon, the seniormost, Senior Environmental Scientist was temporarily appointed as Chief Environmental Scientist as per proceedings read as 2<sup>nd</sup> above. Subsequent to the above appointment, Sri. M.H.Sherafudeen, Environmental Scientist and Sri. K.J Shaji Assistant Environmental Scientist were also temporarily appointed as Senior Environmental Scientist and Environmental Scientist respectively.

The Department Promotion Committee convened on 05.10.2020 considered the eligibility of Sri. V.T Sajimon , Senior Environmental Scientist for inclusion in the select list for 2020 for Chief Environmental Scientist and

found him to be qualified for promotion with effect from F.N of 28.06.2020. Accordingly, the Department Promotion Committee prepared select lists of officers fit for promotion to the cadre of Chief Environmental Scientist, Senior Environmental Scientist and Environmental Scientist for the year 2020 and the select list was published vide notification read as 3<sup>rd</sup> above.

**As such, the following Promotion and Postings of officers are ordered:**

1. Sri. V.T. Sajimon, Senior Environmental Scientist, Central Lab, Ernakulam is promoted to the cadre of Chief Environmental Scientist in the scale of pay of Rs.93000-120000 and posted as such in the existing vacancy.
2. Sri. Sherafudeen M.H., Environmental Scientist, Central Lab, Ernakulam is promoted to the cadre of Senior Environmental Scientist in the scale of pay Rs.85000-117600 and posted as such in the existing vacancy.
3. Sri. K.J. Shaji, Assistant Environmental Scientist, Central Lab, Ernakulam is promoted to the cadre of Environmental Scientist in the scale of pay of Rs.68700-110400 and posted as such in the existing vacancy.



Sajimon for promotion with effect from 28.06.2020 F.N. and also taking into consideration of the fact that he has been holding additional charge of the post from 27.02.2019 onwards and was given temporary appointment as Chief Environmental Scientist under rule 9 (a) (i) of Part II, KS & SSR's owing to exigency of service vide Order 1<sup>st</sup> cited, it is also ordered that the promotion of Sri. V.T. Sajimon as Chief Environmental Scientist will have effect from 28.06.2020 F.N onwards with all consequential benefits, as recommended by the Department Promotion Committee. The promotions now ordered to Sri. M.H.Sherafudeen , Environmental Scientist and Sri. K.J Shaji, Assistant

Environmental Scientist as Senior Environmental Scientist and Environmental Scientist respectively will also have effect from the F.N of 28.06.2020, in the above manner as recommended by the Department Promotion Committee
