**ORDER**

Sri. Jamsheed K.P. [Serial N.6) and Smt. Muhaseena N.T. (serial No.21) who were offered appointment as Assistant Engineer, vide proceedings read 2<sup>nd</sup> above, have informed their unwillingness to join duty. As such it has been decided to issue appointment order to the next candidates from the respective categories in Rank list, prepared by the Board for Kozhikode Region.

As such the following candidates are offered appointment as Assistant Engineer on contract basis in the offices noted against each for a period of 179 days from the date of joining duty or till a regular PSC hand joins duty, whichever is earlier, on a fixed consolidated pay @ ₹ 43,155/- (Forty three Thousand One Hundred and Fifty five only) per month and subject to the acceptance and fulfilment of the usual terms and conditions of contract appointment. Before joining duty, the candidate should have to execute an agreement in non-judicial Indian stamp paper worth ₹ 200/- with the Board.

The service of the contract appointee will be purely on temporarily basis. The appointment is liable to be terminated, in case the performance/conduct of the contract appointees are not found satisfactory. The appointment on contract basis does not entitle the candidates for getting regularised in the service of the Board or confer any claim for regular appointment in future. If any irregularity is noticed later in the recommendation of their name from the Employment Office or in selection of the candidate for posting, their service in the Board will be terminated.

If the terms and conditions of contract appointments are acceptable to the candidate(s) he/she will report for duty before the Officer at the office of posting within 15 ( fifteen ) days of receipt of this order with his photo ID, original documents in proof of age, qualification and community / non-creamy layer certificate and will execute the requisite bond of contract . The candidate will have to submit a certificate of his/her fitness from a Government /Registered Medical Practitioner and a character certificate from a Gazetted Officer. If they fail to join duty on time, posting order issued to such candidates shall stand cancelled automatically and candidate will have no right to claim it.
