The service of the contract appointee will be purely on temporarily basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory. The appointment on contract basis does not entitle the candidate for being regularised in the service of the Board or confer any claim for regular appointment in future. If any irregularity is noticed later in the recommendation of their name from the Employment Office or in selection of the candidate for posting, their service in the Board will be terminated.

If the terms and conditions of contract appointments are acceptable to the candidate(s) he/she will report for duty before the Officer at the office of posting within 15 (fifteen) days of receipt of this order with his photo ID, original documents in proof of age, qualification and community / non-creamy layer certificate and will execute the requisite bond of contract . The candidate will have to submit a certificate of his/her fitness from a Government /Registered Medical Practitioner and a character certificate from a Gazetted Officer. If they fail to join duty in time, posting order issued to such candidates shall stand cancelled automatically and candidate will have no right to claim it .
